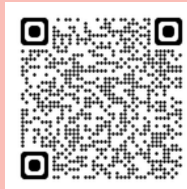
Am I safe and respected? quiz

Answer "Agree" or "Disagree" depending on your circumstances and find out how you are going at the end.

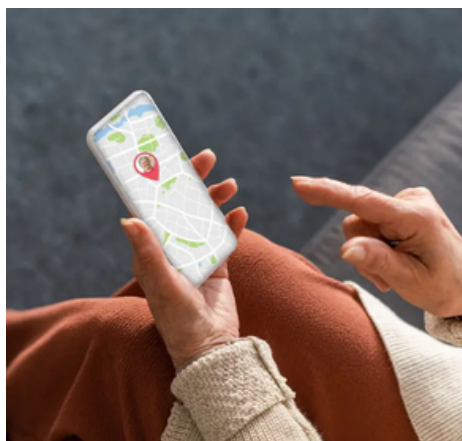
